Subject: **PPCC's RESPONSE: REQUEST FOR NO OBJECTION TO UTILIZE THE SOLE SOURCE METHOD OF PROCUREMENT FOR LEGAL CONSULTANCY SERVICES**

We present compliments and wish to acknowledge receipt of your letter, which sought the approval of the Commission for the Liberia Civil Aviation Authority to use the Sole Source Bidding method of procurement to hire a Consultancy Firm for Legal Services for an upcoming performance Audit of LCAA in early 2021 by the International Civil Aviation Organization (ICAO), for Fiscal Year 2020/2021.

The Commission, upon review of the submitted documentation states below:

- That the justification provided is not consistent with section 55 (1)(d) of the PPCA;
- That the LCAA has not submitted its annual Procurement Plan (2020/2021) along with contract award information for all procurement contracts awarded in the previous Fiscal Year (2019/2020);
- The PPCC, given LCAA's expressed emergency relating to ICAO's Audit, is willing to grant reduction in lead time for said contract package.

The Commission, given these observations advises the LCAA to submit its annual Procurement Plan for FY 2020/2021 and include the contract package for the consulting service.

The LCAA is advised to promptly adhere to the advisory for onwards review and subsequent approval by the Commission.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA 2010 as we jointly aspire to ensure the National Interest is assured and ultimately public confidence is maintained in all Public Procurement and Concession processes.

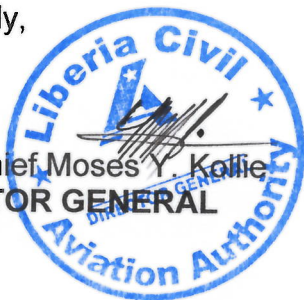
