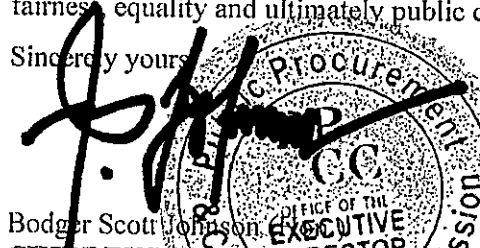

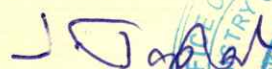

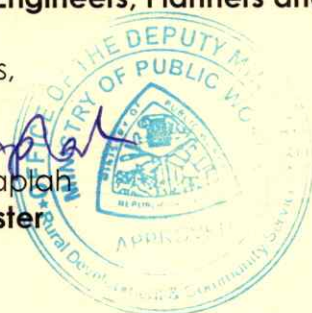
I write to inform you that the Ministry of Public Works conducted bidding processes for the Rehabilitation of **Gio Town to Moin Road (12.0km)** under IFB No. MPW/NRF/W/NCB/009/'25 and the **St. John River Bridge (185m X 1.5m)** under IFB No. MPW/NRF/W/NCB/010/'25 using the National Competitive Bidding Method through the Electronic Government Procurement (e-GP) system. Evaluation panels were constituted for evaluation and recommended to the Procurement Committee **Pacific Construction Company (US\$445,475.11) & Alliance Consulting Engineers, Planners and Surveyors Inc. (US\$484,429.13)** for contract awards respectively.

Due to technical issues beyond our control, these contract packages were not transmitted to PPCC through the e-GP platform. As such, the Ministry likes to officially submit to your office hard copies of these procurement packages for your review and approval.

In this regard, the Ministry of Public Works Procurement Committee likes to inform you of its decision and to seek your approval to award Contracts for the Rehabilitation of **Gio Town to Moin Road (12.0km)** and the Rehabilitation of **St. John River Bridge (185m X 1.5m)** for Fiscal Year 2025 as mentioned above.
