

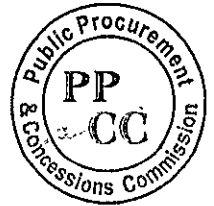

Subject: PPCC RESPONSE: REQUEST FOR "NO OBJECTION" TO AWARD CONTRACT TO LA CLIQUE, INC. FOR THE PROVISION OF AN EVENT PLANNING SERVICE - FISCAL YEAR 2025

We present our compliments and wish to acknowledge receipt of your letter, which sought the approval of the Commission for the National Road Fund Office (NRF) to award a contract to La Clique, Inc. for the provision of an event planning service for an amount of one hundred thirty thousand United States Dollars US\$130,000.00.

The Commission, upon review of your submissions, highlights the following:

- That the NRF submitted hard copies: bid documents, bid evaluation report, procurement committee meeting minutes, bid opening minutes, copy of notification to award, letter of rejection, etc.
- That the NRF BEP's Report indicates that only one submission was received for the advertised contract package: La Clique, Inc.;
- That La Clique, Inc. was deemed the lone responsive bidder as per the NRF BEP's Report;
- That the bidder's submitted contract price (US\$150,000.00) was higher than the NRF's approved amount (US\$130,000.00) for the stipulated contract package;
- That an agreement was reached as per a negotiation meeting held between the NRF and its recommended bidder for the contract amount to be adjusted from US\$150,000.00 to US\$130,000.00.

The Commission, upon overall review of your submission, renders "No Objection" for the National Road Fund Office (NRF) to award a contract to La Clique, Inc. for the provision of an event planning service for an amount of one hundred thirty thousand United States Dollars US\$130,000.00.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain, primarily, in compliance with the PPCA, 2010, as we jointly aspire to achieve Transparency, Accountability, Fairness, Equality and ultimately public confidence in our procurement and concessions processes.

**Subject: Request for “No Objection” to Award Contract to La Clique, Inc. for the Provision of an Event Planner in Favor of the National Road Fund of Liberia, FY 2025.**

I extend my compliments.

This is to request a **“No Objection”** to proceed with the procurement of an Event Planner for the National Road Fund of Liberia’s upcoming hosting of the Africa Road Maintenance Fund Association 22nd General Assembly, scheduled in Monrovia from November 14 to 21, 2025.

This event is expected to host approximately 400 international guests, including CEOs of African Road Funds. As this is our first time hosting such a significant conference, it is crucial we meet regional hosting standards swiftly to maintain our standing internationally. Delays could jeopardize our hosting opportunity.

Our entity conducted a **National Competitive Bidding** process for this non-consultancy service. Four bidding documents were purchased, but only La Clique, Inc. submitted a bid. Following a thorough evaluation, La Clique, Inc. was determined the “only responsive bidder” by the evaluation panel and approved by the National Road Fund’s Procurement Committee as the recommended contractor.

**The contract value exceeds the threshold requiring prior approval from the PPCC before award. The total contract amount is USD 130,000.00 (One Hundred Thirty Thousand United States Dollars).**

According to Section 37 of the Public Procurement and Concession Act (PPCA), “The Procuring Entity shall promptly furnish the Commission notice of each contract awarded in which the price of the contract exceeds the applicable thresholds established by regulations promulgated by the Commission, indicating the reference number used in the bidding process, the contract price, the name and address of the successful bidder, a brief description of the goods, services or work procured, and the procurement method utilized in awarding the contract. The Commission shall cause this information to be published promptly.”

In view of the above, we kindly request the Commission to grant “No Objection” for the award of the event planner contract to La Clique, Inc., the only responsive and recommended bidder, to ensure timely delivery of conference activities.
